

Cyber Monday Online Parts Counter (“OPC”) / MoVi Reward Offer

Official Terms and Conditions

NOT OPEN TO THE GENERAL PUBLIC. Offer will be available November 28th, 2025 to December 1st, 2025, at 12:00:00 a.m. Central Time (“CT”) until 11:59:59 p.m. CT (the “Offer Period”). Offer is provided by Peterbilt® and Kenworth®, both divisions of PACCAR Inc (the “Sponsor”) with applicable rewards administered through the Kenworth, Peterbilt, and TRP loyalty programs. Open to all OPC / MoVi end users in North America, including the United States, Canada and Mexico who are members of the Kenworth, Peterbilt, and TRP loyalty programs and entered a single order in the OPC / MoVi of \$500 USD or more during the Offer Period as described below. **Employees or appointees of any federal, state, provincial, or local government are prohibited from participating.** Void where prohibited. Participation in the Offer constitutes participant’s full and unconditional agreement to these Terms and Conditions and Sponsor’s decisions and interpretations, which are final and binding in all matters related to the Offer. 1. The end user must enter a single order in Online Parts Counter (OPC) / MoVi between November 28th, 2025 to December 1st, 2025, during the Offer Period (a “Qualifying Purchase”).
2. The order must meet or exceed \$500 USD in one single transaction. Orders that meet or exceed the \$500 amount through multiple transactions on December 1, 2025 do not qualify.
3. The single qualifying order must include a mix of SKUs drawn from designated **PACCAR stock classes**. SKUs outside of these stock classes do not count toward meeting the minimum dollar threshold. The applicable stock classes are those listed in the program, including but not limited to power transmission, power generation, cab & frame, truck systems, options/accessories, undercarriage, ride control, and interior & component categories for Kenworth, Peterbilt, and TRP.

Current loyalty offerings may be applied to the single qualifying transaction. Only one reward can be earned per loyalty membership per brand (Kenworth, Peterbilt, and

TRP). The reward will be loaded onto the customer's loyalty account on or before January 1, 2026.

For clarity, a "qualified end user" is an OPC / MoVi user transacting under an eligible loyalty membership in the participating brands listed above. This program is not limited to new members; it applies to OPC / MoVi end users meeting the qualifying purchase criteria on Cyber Monday.

After making a Qualifying Purchase between the Offer Period, qualified end users will earn a reward of \$50 off for future purchases, loaded to their loyalty account. The reward must be redeemed during January 1, 2026 through March 31, 2026. Rewards not redeemed within this period will expire and will not be reinstated. Rewards have no cash value and are not transferable. No cash redemption or refunds will be provided.
